# COUNCIL CHAMBER - CITY HALL - GADSDEN, ALABAMA JANUARY 29, 2019 - 11:00 A.M.

The City Council met on January 29, 2019, in regular session.

The meeting was called to order at 11:00 a.m. by Council President Toles. On roll call by the City Clerk, Iva Nelson, the following council members answered present: Toles, Williams, Worthy, Back, Wilson, and Reed. Councilman Cannon was absent. The clerk stated a quorum was present and the meeting was open for business. Mayor Guyton, Heath Williamson, Lee Roberts and Chief Jaggears were also present.

The invocation was given by Councilman Wilson.

The minutes of the last work session and council meeting held on January 23, 2019, were approved by unanimous vote.

Payment of the HTE System accounts for the week of January 18 - 24, 2019 were ratified by unanimous vote.

## **PUBLIC HEARINGS**

President Toles stated this was the time and place as advertised to conduct the following public hearings:

Brian Harbison, Building Inspector, stated no improvements have been made since procedures began in April 2018, and recommended abatement. (4) President Toles advised that due to the threat of a winter weather event, the City Council met in special session on January 28 and canvassed the results of the referendum election held on January 22. She cited the final results (1,245 "yes"; 563 "no"), which indicated that an elected school board is favored by a majority of voters who participated in the election.

Councilman Williams moved to adopt the ordinance, which motion was seconded by Councilman Worthy and unanimously adopted.
