COUNCIL CHAMBER - CITY HALL - GADSDEN, ALABAMA APRIL 27, 2021 - 11:00 A.M.

The City Council met on April 27, 2021 in regular session.

The meeting was called to order at 11:00 a.m. by Council President Toles. On roll call by the City Clerk, Iva Nelson, the following council members answered present: Toles, Williams, Worthy, Back, Wilson, Cannon and Reed. The clerk stated a quorum was present and the meeting was open for business. Mayor Guyton, Heath Williamson, Lee Roberts, and Captain Jackson were also present.

The invocation was given by Brian Harbison.

Deborah Gaither, Emergency Management Agency Director, noted today is the tenth anniversary of the deadly outbreak of tornadoes in Alabama on April 27, 2011. She reported low participation in last week's vaccination clinic at Elliott Community Center and announced today's clinic at Carver Community Center. Ms. Gaither encouraged citizens to be vaccinated and noted walk-ins are accepted on Tuesday and Thursday mornings at the health center.

The minutes of the last work session and council meeting held on April 20, 2021, were approved by unanimous vote.

DEPARTMENT REPORTS

Jennifer Weathington, Parks & Recreation Director, announced a number of upcoming events and programs. On behalf of the Carver Revitalization Committee, she announced First Saturday in Carver Square and noted First Friday and the Summer Concert series will resume in June. Ms. Weathington encouraged citizens to apply for available positions.

CITIZEN REQUEST

Larry Suttles expressed appreciation for work that is progressing on trash collections and cleaning of ditches and drains. He pledged to continue pushing for the work to be completed. Mr. Suttles also referred to a person entering a vacant house that has now been condemned.

MAYOR AND COUNCIL REMARKS

Councilman Back advised residents the State of Alabama will soon begin resurfacing Highway 411, including all areas within the city. Medians will be altered in the course of work and will be addressed after paving is complete. He commended "Friends of the Falls" for their work in collecting litter and thanked Mr. Suttles for his energy and concern for the city.

Councilman Wilson commended the expertise and efforts of Susan Little, who worked for historic designation of her neighborhood by the Alabama Historical Commission and remains committed to serving on the Turrentine Architectural Review Board.

Councilman Reed thanked Chet Hallman (Twin Bridges Golf Course Manager) and everyone who helped with yesterday's Gadsden Etowah Patriots Association golf tournament. Councilman Wilson complimented the greens and expressed appreciation for the city's large investment in replacing them.

Councilman Cannon thanked a number of people who have been picking up litter on several streets in Alabama City, noting it quickly reappears, and asked the public to not litter.

Councilman Worthy thanked Pastor Betty Robinson and EMA for their work on the Carver vaccination clinic. He affirmed his commitment to represent and assist all residents, whether or not they voted for him.

Mayor Guyton commended EMA and encouraged everyone to be vaccinated and avoid contact with "super spreaders".

President Toles encouraged people to apply for police and fire department positions.

There being no further business to come before the Council, the meeting was duly adjourned.
