# COUNCIL CHAMBER - CITY HALL - GADSDEN, ALABAMA MAY 25, 2021 - 11:00 A.M.

The City Council met on May 25, 2021, in regular session.

The meeting was called to order at 11:00 a.m. by Council President Toles. On roll call by the City Clerk, Iva Nelson, the following council members answered present: Toles, Worthy, Back, Wilson, Cannon and Reed. Councilman Williams was absent. The clerk stated a quorum was present and the meeting was open for business. Mayor Guyton, Heath Williamson, Lee Roberts and Captain Jackson were also present.

The invocation was given by Brian Harbison.

Deborah Gaither, EMA Director, stated Covid cases in Etowah County total 13,954, with 357 deaths. She noted second doses for those vaccinated at Carver Community Center are available at the health department next week, which will conduct vaccinations each Thursday from 8:30 to 3:30. Ms. Gaither announced a second mid-action review meeting of the pandemic on Thursday from 9 a.m. until noon and the next conference call at 11 a.m. on June 16. In response to inquiries, she noted reopening drinking fountains is a local decision and a decision regarding booster vaccines is expected in late August.

The minutes of the last work session and council meeting held on May 18, 2021, were approved by unanimous vote.

Payment of the HTE System accounts for the week of May 14-20 were ratified by unanimous vote.

## MAYOR AND COUNCIL REMARKS

President Toles announced changes in the garbage collection schedule due to next Monday's Memorial Day holiday.

Councilman Reed announced a memorial program to be presented by the Gadsden Etowah Patriots Association at the War Memorial on Monday.

Councilman Wilson explained some of today's actions taken and thanked Striplin Elementary for inviting him to the super citizens program. He thanked first responders for their good work at a terrible accident in the downtown area. Councilman Wilson announced a voucher program for seniors to participate in local farmer's markets, offered by the Alabama Extension office.

On behalf of Councilman Williams, City Clerk Iva Nelson read a statement from him thanking everyone for their concerns expressed during the illness of his parents.

Councilman Back congratulated the Westbrook baseball team who won the State championship.

Mayor Guyton said social media statements regarding the rendering plant being a "done deal" are not true.

Councilman Worthy encouraged everyone to be safe during the upcoming holiday.
