

ORDINANCE NO. 0-01-18

Amending Fiscal Year 2017 Community Development Block Grant Budget And Action Plan, And Authorizing Fiscal Year 2017 Community Development Block Grant Subrecipient Allocations And Agreements

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF GADSDEN, ALABAMA, as follows:

Section 1. The document entitled Community Development Block Grant Program Fiscal Year 2017 budget, totaling \$945,735.00, filed with the City Clerk-Treasurer, together with all schedules and exhibits thereto, was adopted by City Council Ordinance No.0-12-17, as the budget of authorized expenditures by the City of Gadsden for the Community Development Block Grant to be received from the United States Department of Housing and Urban Development for the Fiscal Year 2017 Community Development Block Grant Program year beginning June 1, 2017 and ending May 31, 2018, and from projected program income. The actual FY2017 Community Development Block Grant Program appropriation received from the U.S. Department of Housing and Urban Development was greater than the estimated budget. The Fiscal Year 2017 Community Development Block Grant budget is hereby amended to \$972,970.00, and is adopted as the Fiscal Year 2017 Community Development Block Grant budget.

Section 2. The document entitled City of Gadsden FY2017 Annual Action Plan was adopted by the City Council by Ordinance No. 0-12-17 as the one-year use of CDBG funds action strategy to complete the goal of meeting the needs set forth in the FY2015-FY2019 Consolidated Plan Action Plan. The FY2017 Annual Action Plan is hereby amended and adopted to include the increased appropriation by increasing the line item budget for Housing Assistance from \$120,000.00 to \$126,500.00.

Section 3. The FY2017 Community Development Block Grant budget appropriates the amount of \$93,000.00 to Public Services. The Mayor on behalf of the City is hereby authorized to enter into a contract with each organization for the performance of a public service in the amount authorized in the Fiscal Year 2017 Community Development Block Grant budget.

Section 4. The Planning Office, the Community Development Office, and the City Clerk shall Maintain true and correct copies of the Fiscal Year 2017 Community Development Block

Grant Annual Action Plan, and the Fiscal Year 2017 Community Development Block Grant budget in their offices at all times during the program year. The Director of Finance shall maintain a true and correct copy of the Fiscal Year 2017 Community Development Block Grant Budget in her office at all times during the program year.
